LANGARA STUDENTS' UNION ("LSU") SPECIAL RESOLUTIONS **SPECIAL RESOLUTION 1**

WHEREAS:

The "Legal Care Program" provides:

- unlimited legal representation in housing, employment, and academic rights, as well as public notaries (through "The Essentials" component of the Program)
- unlimited legal consultation for any area of the law (i.e. immigra- Legal Consultation: tion law, corporate law, disputing parking tickets, etc.) at no additional cost to the members

Whereas Langara Students' Union members approved, by a referendum vote in summer 2022, the implementation of a "Legal Care Program" at an annual cost of \$33 as of September 01, 2022.

Whereas "Langara College" has been unable to assess this fee to students, and therefore the Langara Students' Union has been temporarily funding this program through its internal reserves since January 01, 2023.

This program is uncapped, meaning that a student can access it as often as needed, there are no limits on the time spent on an issue or case, and there are no limits on the legal expenses and lawyer fees accumulated on a case.

Students will have access to true legal consultation with specialized lawyers to discuss any legal questions or issues they may be facing on any topic. The confidential and privileged consultation can span over as many meetings as necessary to resolve the issue, and students will receive researched and specific legal opinions and advice. No area of the law is excluded, and topics can range from questions about immigration law (e.g. study permit extensions), criminal law (e.g. traffic violations), and consumer law (e.g. privacy violations) all the way to intellectual property law.

Legal Representation (The Essentials):

Lawyers will take charge of all the steps and legal actions required to resolve housing disputes, employment disputes, and disputes with the academic institution:

*Please note: Should this special resolution fail to pass, the LSU may consider placing this service on hold until Langara College can assess this fee separately to LSU members.

Legal Care Program: Summary

Disputes with landlords, employers, academic institutions, or any other legal issues can be intimidating and difficult to navigate as a student, especially since finding and engaging a lawyer can be a lengthy and costly process.

This Program's main purpose is to improve access to justice for students by offering a legal counselling service that allows students to consult a lawyer on all legal topics. After the initial intake process, students will be in touch with legal partners within 24 to 48 business hours to start the confidential and privileged legal consultation. These consultations with lawyers can be in person, virtual, or over the phone, and will last as long as necessary to resolve the issues. Moreover, this Program includes legal representation in key areas of law that particularly affect students' lives.

Disputes with an academic institution – A student's legal expenses in the event of a dispute with an academic institution. This excludes cases related to sexual misconduct or a criminal act.

<u>Public Notaries</u> – Members who require commissioning services can arrange for virtual meetings to commission affidavits. Notarizing services are also offered.
